NTA has taken a leading role in facilitating Chinese inbound leisure group travel to the United States by creating the China Inbound Program. In accordance with a [Memorandum of Understanding](#) signed by the United States and China Dec. 11, 2007, private sector associations can submit lists of qualified tour operators to the China National Tourism Administration. The "approved" list of operators must attest that these companies can ensure the highest quality visitor experience for these groups.

NTA is the only U.S.-based trade association to have a tour operator qualification program approved by the China National Tourism Administration.
